THE ORGANIZATION WORKS TO END THE HARMFUL PRACTICE OF SEPARATING CHILDREN FROM THEIR FAMILIES AND RAISING THEM IN AN ORPHANAGE. THERE ARE AN ESTIMATED EIGHT MILLION CHILDREN GLOBALLY LIVING IN RESIDENTIAL INSTITUTIONS (SOMETIMES KNOWN AS ORPHANAGES) THAT SERIOUSLY HARM THEIR HEALTH AND DEVELOPMENT AND REDUCE THEIR LIFE CHANCES. MORE THAN 80% OF THESE CHILDREN ARE NOT ORPHANS BUT HAVE AT LEAST ONE LIVING PARENT. MOST ARE PLACED IN INSTITUTIONS BECAUSE THEIR FAMILIES ARE POOR, OR BECAUSE THE CHILD HAS A DISABILITY AND THERE ARE NO COMMUNITY-BASED INCLUSIVE HEALTH AND EDUCATION SERVICES.
