Senior Programs - The programs include senior referrals, educational programs, tax preparation assistance program, and driver safety course. It reminded and informed people for the health insurance enrollment for the period from November 1 through December 15. On November 19, 2017, it held the 2nd Annual Health Wellness Fair with APIA Healthcare providers offering free screenings and healthcare enrollment. On March 11, 2017, the first Health and Resource Fair was launched. The goal was to provide the Asian American and Pacific Islander free health service and education of health program available in Nevada. The organization also partnered with AARPs Foundation Tax Aid Program to provide a valuable service to the community for the tax season. The staff went through a week long certification program involving hours of learning the new software for tax return preparation and the tax codes for some of the younger staff members.
