Its initial bylaws referred to the Organization as "Homeless Family Foundation of Indian River County, Inc." In February of 2015, the Organization amended its Articles of Incorporation to change its name to "Homeless Children's Foundation of Indian River County, Inc." On July 7, 2015, the Organization filed its Form 1023, Application for Recognition of Exemption, with the IRS. Its Form 1023 application packet included copies of the initial Articles of Incorporation (with proof of filing) and the Amended Articles of Incorporation (with proof of filing). The Organization identified itself as "Homeless Children's Foundation of Indian River County, Inc." on its Form 1023, its initial Form 990-EZ, and all subsequently filed Forms 990 (including this Form 990). On February 23, 2017, the Board of Directors of the Organization resolved that wherever the name, "Homeless Family Foundation of Indian River County, Inc." appeared in its bylaws, it was to be replaced with the name, "Homeless Children's Foundation of Indian River County, Inc." The purpose of this action was merely to cause the Organization's bylaws to reflect the 2015 name change (which was previously communicated to the IRS in the Organization's Form 1023). The 2015 Amendment to the Articles of Incorporation and proof of filing with the Florida Department of State is attached as Exhibit A. Furthermore, a copy of the 2017 Resolution amending the bylaws to reflect the 2015 name change is attached as Exhibit B.

Each then-serving Director was given an opportunity to review and comment upon drafts of the Form 990 between February of 2018 and the time of filing.
