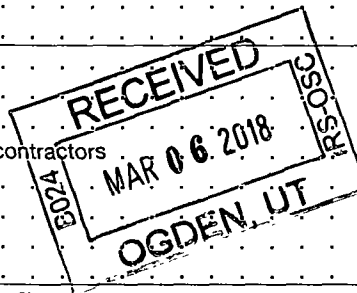

Supplemental Information for Parts III and IV

The organization's primary purpose remains as last year, to provide financial assistance to wheel chair bound veterans who cannot drive, that must be transported in a medically equipped van to their medical appointments at the Veterans Medical Center in Salem, Virginia. This year the organization has broadened its assistance to include helping veterans in the Lynchburg area, plus the 5 surrounding counties of Bedford, Amherst, Campbell, Appomattox and Nelson, who are in dire financial straits. This included help with heating, electrical, rent, transportation and food. The organization has a screening process in place to assess the veteran's financial situation, then to assist any eligible veteran apply for VA benefits, and then assist financially in emergency situations. The organization refers veterans to financial counseling programs if it appears the veteran is unable to manage money. The organization assisted several homeless veterans this year find respectable housing. The Lynchburg Area Veterans Council, Inc. was responsible for planning, soliciting sponsors, and executing the first Lynchburg Veterans Day Parade since 1938. The morale generated among the veterans in the central Virginia area was amazing. We had approximately 25 World War II veterans actually in the parade on a very cold November 11 morning. This was the organization's most expensive program, but it generated the greatest amount of funds for 2017. A portion of the funds (\$18,835.52) was distributed in grants to our partner organizations, The American Legion Post 16 Lynchburg, Military Order of the Purple Heart Lynchburg Chapter, and Vietnam Veterans of America Lynchburg Chapter. Other funds (\$10,059.92) were used to support veterans on an individual basis, as mentioned above with the financial assistance and wheel chair transportation. This is represented by the figure on line 10, Part I.

Expenses for the organization consisted of the Parade expenses (\$4937 on line 28a) expenses for a 9/11 Run event and craft fair (\$2,389 on line 29a); plus printing expenses for flyers, brochures and signs for all of the events (\$1047 on line 31a).
