Conservation X Labs' mission is to harness exponential technologies, open innovation, and entrepreneurship to dramatically improve the efficacy, cost, speed, scale and sustainability of conservation efforts to end human induced extinction.

The Blue Economy Challenge and Oceans X Labs. Conservation X Labs, working in partnership with the World Wildlife Foundation, sought to bring to scale innovations that were identified through the Blue Economy Challenge, which was run with the support of the World Wildlife Fund and the Department of Foreign Affairs and Trade of the Government of Australia on replacing wild fish in aquaculture feed with more sustainable substitute, improving aquaculture design, & developing new sustainable ocean products. Through our partnership with WWF, we pioneered the first accelerator focused on ocean conservation, and brought the innovations from the Blue Economy Challenge to scale. Conservation X Labs developed extensive bespoke programming, coupled with access to WWF and CXL's global conservation networks, industry, and sustainability experts, world class science, technology, and engineering, and impact investors, industry experts, and development finance institutions, to help the companies in our first cohort succeed. The companies in the cohort got access to millions of dollars of grants and investment through the accelerator.

Conservation X Labs has developed the world's first digital makerspace - a mass collaboration platform to help develop conservation technologies and innovations, and create a community for innovation within conservation. This program was a spin out of Oceans X Labs. We designed the Digital Makerspace as a digital engineering workshop, collaboration space, and project pipeline where ideas can be born, tested, and developed. The DMS supports all of Conservation X Labs' programs and activities—across the entire innovation pipeline from idea to scaled solution—as well as hosts the Conservation 3.0 tribe. It is where science, entrepreneurship, and technology communities come together to start projects and co-create tech-enabled solutions to conservation problems. It is our online, open community that facilitates ideation, development, and scaling of solutions by the entire crowd. The platform, The platform, coupled with other CXL programs, is engineered to support projects that are born on the Digital Makerspace and help transform the most promising and transformative ideas into financially sustainable viable products, teams, and companies that will help to end extinction.

Conservation X Labs has been building a DNA Barcode Identification Tool - a portable, battery-powered, pocket-sized, rapid, ultralow cost tool to permit species identification in the field without the use of a lab, reagents, expensive equipment, or specialized training or expertise. The development of the tool, which is being engineered in partnership with the University of Washington nanofabrication facility, would accelerate species identification using DNA Barcodes - short sequence genes, such as the CO1 gene for vertebrates that correspond with species identity. Through the development of a low-cost, battery powered device, we can democratize the use of genetic technologies at the frontlines of conservation, where they are needed most. Our first use case is to use the tool to combat fraudulent mis-identification of fish, which undermines fisheries conservation and harms consumers. We also intend to use the device to combat wildlife and timber trafficking, and detect pathogens and invasive species in the wild through environmental DNA. Our engineering goals are to simplify the device to work with

Conservation X Labs, Inc's (a 501c3 DC C-Corporation) mission is to end human induced extinction through harnessing exponential technologies, open innovation, and entrepreneurship. It has a related organization – a Delaware Public Benefit Corporation (structured like a DE C-Corporation) – that has the identical mission. The purpose of the related organization is to help scale and sustain new breakthrough technologies that can have a dramatic effect on the environment by helping with the commercialization of that technology. Over time, as the two organizations grow, we will develop separate staffing, and more distinct operational mandates. We believe the interaction with the related organization allows Conservation X Labs Inc (501c3) to achieve greater impact on a global scale, furthering the goals of the public trust behind our core organization.

The related organization (Conservation X Labs, PBC) transferred funding to the nonprofit for expenses incurred through work on a conservation contract. \$38,000 was transferred from a contract with the related organization by the Department of Interior to use innovation & technology to combat invasive species. The reimbursement was used to reimburse expenses incurred in the performance of that contract. The nonprofit later transferred back \$5,000 to the related organization (Conservation X Labs, PBC) as the related organization needed to pay for operational funds related to the DOI contract.

Conservation X Labs, Inc (501c3) also reimbursed the related organization (Conservation X Labs, PBC) for its payment in support of Duke Blueprint, a conservation technology engineering competition run by and for students at Duke University.
