These unique programs touch on the areas of character building, the fostering of kindness and empathy, personal physical fitness, and helping children to architect a "core" of self-valuing that is essential in dealing with the world they live in. 59 live educational emotional intelligence and anti-bullying concerts were given at 23 elementary schools, 4 middle schools & 3 high schools representing 9 Independent School Districts located throughout Texas, 1 children's hospital in Texas, 1 elementary school in Kansas, and 3 libraries in Colorado serving a total of 16,828 students plus 960 teachers and administrators. 2 week long camps were given for 1,000 homeless children in Dallas, TX.
