Multiple mission teams visited Sierra Leone, specifically the Rotifunk area, in February, August and November 2017, to review the Rotifunk Hospital's current and future operations. With the cash contributions raised in 2017, the operating room was equipped and is now in service. In addition to operating room equipment, a vehicle was purchased for hospital transportation.
