Our foundation works to bring patients of pulmonary hypertension to early and accurate diagnosis. This disease is often misdiagnosed or under diagnosed, leading to delays in treatment. Delays are generally up to 2 or more years after symptom onset. Poor diagnosis rates for patients of this disease may suffer irreparable harm to the heart and lungs, leading to heart failure and premature death.

Blue Lips issued research funding to Stanford University Medical Center in support of work to study novel biomarker recognition of pulmonary hypertension, including proteomic signatures in a patient's blood. The study focused on clustering of cells which provided benchmark data to whether a patient is a pulmonary hypertension candidate, the classification of pulmonary hypertension, and the condition of disease state.
