Among the significant changes were: - Creation of a sole member: o The new bylaws define the sole member as Audra Colson, current CEO/Founder. - The new bylaws define corporate actions that require approval of the sole member, including changes to directors and officers, amendments to articles of incorporation, amendments to the bylaws, and merger, consolidation, or dissolution of the corporation. - The new bylaws address compensation of the Board of Directors, whereas the old bylaws did not. Specifically, Directors of the Corporation shall not receive compensation for serving as Directors, but may receive reasonable compensation for other personal services rendered which are necessary to carrying out the exempt purposes of the Corporation. - Voting approval requirements: The old bylaws used consensus procedures/voting. The new bylaws use an act of majority (51%). - Duties of President - The new bylaws remove the written requirement that the president review monthly reconciliations and financials no later than the 25th of the following month. - Treasurer: The new bylaws summarize the Treasurer's duties as overseeing the development and observation of the organization's financial policies, budgeting, reporting to the Board and serve as Chair of the Finance Committee. - The old bylaws had a very specific list of tasks. - Conflict of Interest: The new bylaws include a conflict of interest section, and a conflict of interest policy was also adopted. - Whistleblower: A whistleblower policy was adopted. - Records Retention: A records retention policy was adopted.
