<p><b>30</b>                      "Carverponics" has been supporting science classes with hands-on STEM and agricultural science programming in Richmond Public Schools (RPS) since 2013. Primary benefiting schools have been Carver Elementary School, Richmond Technical Center (RTC), and Armstrong High School. Carverponics has brought 800 volunteer service hours to bolster RPS STEM, and hosted 35 workshops to over 750 individual students. In 2017 we served the Armstrong H S after-school program and the RTC horticulture program. We designed, installed, and stocked a 500-gallon greenhouse aquaponic system and set up two greenhouse hydroponic systems at the RTC. At Armstrong HS, we provided instructors for two technical classes, 3D Design and Urban Agriculture. Each class met once a week for the duration of the school year.
