La Placita is an open-door venue for community members to explore their ability to produce and commercialize any given product without the pressure of major upfront investment. Within La Placita's operations, each vending start-up is guided and prompted to engage in learning the commercialization of products and services. Product presentation, market analysis and forward planning are imbedded in the process for learning how to build a path to financial success. During 2017, nearly 40 local vendors and organizations took advantage of La Placita at Bethany Park. It served over 7,000 residents while promoting community engagement and the incubation of future businesses for the Central Avenue Commercial Corridor.
