

Riley County Senior Service Center (RCSSC)

Mission: To provide services and activities for older adults 60 years and above living in Riley County, Kansas. The City of Manhattan provides the building. Various activities also raised funding for the activities. Volunteers provide over 2000 hours of volunteer services in almost every facet of the Center operations and services.

Home Care & Hospice, Inc.

Mission: Funding provided by the Riley County Council on Aging was used in the Health Care Attendant Program which involves providing assistance to clients in need of bathing, medication reminders, dressing, grooming and toilet needs under the direction of a licensed health care professional. Volunteers provide assistance with light housekeeping duties, laundry, essential shopping, errands and meal preparation. It is the only agency provider of Older American Act services in Riley County. Its services include Care Management Programs, Bereavement Support Groups, Transition Services Program, Transportation services, Cancer Resource Task Force, Riley County Council of Social Services Agencies and the Annual Flu Vaccination and Tuberculosis Testing Programs.

Flint Hills Volunteer Center (RSVP)

Mission: To provide opportunities for those 14 years and older to volunteer their services and to make a difference in their community. It is a one-to-one volunteer referral agency serving residents throughout Riley, Pottawatomie and Geary County in Kansas. The Volunteer Center matches the skills and interests of its pool of volunteers with the needs of service organizations already helping area residents. Some volunteer activities include working in a local clinic, area blood drives, providing transportation to elderly, tutoring, SASA advocates and teaching reading skills to students.
