Mission Trips and Spiritual Enrichment- DYM took three mission trips in 2017. Two trips to Nicaragua one with adults only where the adults put a roof on a Christian school. The second one included teenagers where they traveled 1,025 miles to 11 towns to present the gospel through drama, music and relationship building with the people of Nicaragua. The teens and adults also attended Lead the Cause in Denver CO where they experienced first hand, leading souls to Christ. Total of 54 participated in Mission trips and spiritual enrichment trips.

DeSoto Youth Ministries continued serving teens in 2017 through a variety of programs, events, and trips. 1,284 attended Extreme Life and 633 attended our leaderships development group Extreme Core, plus 189 attended 5 other special events and fun days. More than 300 young adults met weekly through Extreme Edge where they were given opportunities to lead and to serve.

Staff traveled over 2,500 miles in 2017 following a youth rodeo association to 10 different communities where 19 rodeos were held. Youth and families were served at each rodeo, helping inside and outside the arena. 9 church services were provided for families on Sunday mornings before the rodeos with a combined church attendance of 1,425.
