educating our members, and providing them with resources to help research legal issues they

face

Washburn University School of Law, for the second annual Agricultural Law and Business

Symposium. The Symposium educates Kansas practitioners on current agricultural law, taxation,

and economic issues within the state, so they are better able to serve farmers and ranchers

The Symposium has been attended by over 200 persons in just the first two years. The Legal

Foundation also contributes funds to both Kansas State University and Washburn University

School of Law to help promote agricultural law education and outreach within the state.
