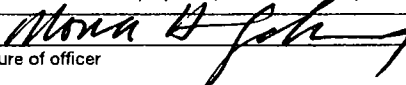

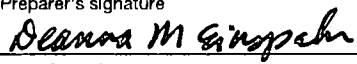

The Friends of the Santa Fe Public Library supplements the Santa Fe Public Library's Books and Materials budget, the Library's E-books and Services and Technology budget, and contributes supplemental funding for Furnishings, Fixtures and Equipment. The Friends also provide Continuing Education funds for Library staff.

4b (Code:) (Expenses \$ 26,024 including grants of \$ 0) (Revenue \$ 0)

The Friends of the Santa Fe Public Library provides funding for Early Childhood and Youth After-school and Summer Reading programs at all three Santa Fe Public Library branches. In 2017, there were a total of 462 Early Childhood and Youth programs that served 15,846 participants. Main Library held 141 programs for 4,188 participants, La Farge Library conducted 122 programs for 3,449 participants; and Southside Library held 199 programs for 8,209 participants. The six-week Summer Reading Program is held annually at all three branches. To entice children to participate, magicians, puppet shows, singers and storytellers put on performances tied to a general reading theme each week. Participants also received weekly incentives to encourage continued attendance. In 2017, 1,502 children participated. Southside Library led attendance with 687 participants, followed by Main Library with 605 participants and La Farge Library with 210 participants.

With funding from the Brindle Fund at the Santa Fe Community Foundation, and an Anonymous donor, the Friends of the Santa Fe Public Library funds Books and Babies, a year-round, early childhood reading and activities program for caretakers and children aged six months to two years. In 2017, sessions were offered in both English and Spanish. In 2017, 8 six-week sessions were held at all three library branches for a total of 5,521 participants.
