Public Education and Conference The NACAC conference in Atlanta, Georgia served about 800 adoptive parents, adoption professionals, and others committed to achieving permanence for children in foster care. Participants attended almost 90 educational sessions where they learned how to better support children with disabilities and other challenges, recruit and prepare permanent families for kids, replicate model programs, change the system to improve outcomes for vulnerable children and their families, and much more. NACAC offered training in person and through webinars to thousands of adoption community members during 2017 on topics such as parent group development, effective support services for families, transracial parenting, core issues in adoption, and adoption competence. NACAC also helped hundreds of prospective adopters find the information they need to navigate the adoption process, and the NACAC website provides in-depth information on adoption issues to tens of thousands of site visitors each year.

Form 990, Part III, Line 4b:

Community Champions Network Through Community Champions Network, which operates across the U S and Canada, NACAC worked with 27 local parent support groups to improve the services they offer, trained 26 parent group leaders, supported the continued development of two newer foster/adoptive parent associations, and helped several communities with their efforts to enhance available post-adoption services. Community Champions Network also provided training to 30 youth leaders and staff about how to create and expand youth support and advocacy networks. At the annual NACAC conference, we provided additional leadership and advocacy training to 21 youth and staff supporters. During the year, we helped nine groups either create or expand their youth support services. We also supported a youth advisory team with 14 individuals who had experienced foster care or adoption. The youth advisory team is able to share their expertise with others in the child welfare field through training, technical assistance, and providing input.

Form 990, Part III, Line 4c:

Adoption Support Network The Adoption Support Network (ASN) provides support to adoptive parents across Minnesota. During 2017, ASN operated 30 support groups and provided one-on-one peer support to hundreds of adoptive families. The ASN private Facebook groups had more than 2,000 members who shared resources with one another and provided mutual support during difficult times. Staff also provided one-on-one support to several hundred families. These services for families raising children with special needs helped reduce families' isolation, increased their ability to meet their children's needs, increased families' stability, and prevented adoption disruptions.
