Philanthropy Development & Community Building SVP engages and enables members and prospective members to become more informed and effective donors. We host workshops and seminars where people learn from each other, from nonprofit professionals, and from subject-matter experts. Through SVP's activities and other community events, we also actively cultivate connections and relationships with cross-sector organizations in order to connect and collaborate to support positive social change and amplify our impact. Some of the most high-impact learning experiences for partners are participating in the grantmaking process, volunteering on capacity-building projects, or coaching a social entrepreneur in the Fast Pitch program. Based on the most recent survey of SVP Partners, 92% indicated that their annual giving to charitable causes has increased since joining SVP, and 77% indicate that SVP has influenced their giving level. For example, a number of our members have made direct personal contributions to these and other nonprofits they learned about through our due diligence process and other programs. We estimate these additional contributions over time to total more than \$2,000,000. Partners also indicate that they have become more involved in the community at large, particularly in volunteering, and 73% say SVP has had an influence on this. The survey results also indicate that Partners are employing a wider variety of decision-making practices considered by the philanthropic community to be "strategic" in nature, such as using formal selection and evaluation processes, and collaborating with other funders/donors to understand community needs, make informed grant decisions, and have greater impact.

Encore Fellowships are designed to bring new talent to organizations solving critical social problems. The Fellowships are structured assignments that place highly-skilled, experienced professionals from the private-sector into social-purpose organizations, where they help nonprofits build capacity, and ultimately, have a greater impact on their communities. Fellows commit to 1,000 hours of work over 6-12 months and earn a \$25,000 stipend while learning about nonprofit innovations, challenges and culture firsthand and providing strategic guidance to strengthen a nonprofit in their community. SVP's role was to identify nonprofits in the Los Angeles area that could benefit from a Fellow's expertise, to recruit and match Fellows with these nonprofits, and to support them throughout their assignments. Encore Fellows also receive a one year membership in SVP. The program results in stronger, more sustainable nonprofits as well as highly-skilled individuals whose passion for and knowledge of the social sector is increased. 8 Fellows were matched with nonprofit organizations in 2017. 91% of nonprofit work hosts would recommend this program to others, and 95% expect sustained positive impact from the Fellowship. 93% of Fellows reported they are likely to continue to work in the nonprofit sector. In October 2017, the SVP Board decided to sunset SVP's involvement in the Encore Fellows Program. While the impact was significant, SVP determined we are not in a position to scale the program.

All employment agreements, when utilized, are negotiated on an arm's length basis, in accordance with the organization's conflict of interest policy. Steps are taken to ensure compensation is consistent with the fair market value for such arrangement by comparing the compensation of employees in the nonprofit sector providing similar services (e.g., other Social Venture Partners member organizations in the U.S., industry compensation surveys, or similar) with comparable levels of experience and expertise. Fee arrangements for independent contractors are negotiated annually and within a competitive market environment for firms offering similar services.
