Supported the Marine Chemist certification process entailing a comprehensive training program. Initial certification requires a trainee to meet extensive education professional and general requirements. Satisfactory completion of an examination and interview with the Marine Chemist Qualification Board is required. The examination and interview includes all aspects of the National Fire Protection Association Standard 306, Gas Hazards Aboard Vessels, and all applicable regulations of the U. S. Coast Guard and Occupational Safety and Health Administration. Certification qualifies the Marine Chemist to determine whether alteration, repair or construction of marine vessels and facilities can be safely undertaken.

The Marine Chemist Qualification Board certifies all initial candidates and re-certifies existing Marine Chemists every five years.

In 2017, ninety-five Marine Chemists were served.

Supported advancement of Marine Chemist professional qualifications by supporting four educational/technical seminars. These provide opportunity to disseminate information on current rules and regulations, provide opportunity for exchange of views, development of professional policies, presentation of technical papers and interface with personnel in the marine industry.

Support the administration of paper and electronic certificates required to be issued by Marine Chemists to authorize work in spaces that may be hazardous.
