Friendship Programs Middle Schools, High Schools, Colleges, and CitizensThe Best Buddies International friendship programs match volunteers with and without intellectual and developmental disabilities (IDD) in one-to-one friendship matches through four unique programs Middle Schools, High Schools, Colleges, and Citizens Best Buddies has grown from a single college program, started at Georgetown University in 1989, and has grown to 2,498 global chapters in 47 countries The Best Buddies' friendship programs year in review below showcases the progress being made globally to reach our 2020 initiative Best Buddies Citizens Best Buddies adult friendship opportunities have seen significant expansion this year, with renewed commitment to expanding community pairs in large markets, and in states without formal citizens programs through the development of citizen chapters at many organizational partnerships The Best Buddies New York Board's program committee has committed to recruiting and meeting with potential volunteers for the New York citizens program, hoping to increase community participation over the next year Given the committee's talents and expertise, they are working with the Best Buddies data team to build new matching analytics to create the strongest, most sustainable community friendship pairs In Illinois, the central region is focusing on building citizen programs at partner organizations based on citizen chapter success that much of the Midwest has seen, especially inspired by Best Buddies Iowa's strong chapter presence in Des Moines area organizations Through support from volunteers and community organizations, Best Buddies citizens is eager to see its largest growth year to date Best Buddies CollegesThe original Best Buddies program continues to expand and find success in regional states working to grow interest and support in establishing Best Buddies offices College chapter programs have been instrumental in driving mission-focused awareness and promoting expansion opportunities in areas from Maine to Oregon The college chapter at the University of Maine met with legislators twice this spring to advocate for community buy-in and investment in programs statewide Similarly, efforts are being launched with volunteer boards and college students working side by side to drive growth in Michigan and Oregon, college leaders are instrumental in spreading the mission of Best Buddies Additionally, college volunteers have been mobilized to meet the growing need for matches in the e-Buddies program With an overwhelming interest from buddy participants between the ages of 18 and 22 to join e-Buddies, efforts have been made to inform and recruit college students to participate in this additional program to create new friendships online and further engage in the Best Buddies mission Best Buddies High Schools The Best Buddies high school program has seen significant increase this year as Best Buddies staff works to streamline management and oversight of chapters to allow for greater and faster growth of new programs In 2017, Best Buddies high school programs grew to an all-time high of 1,197 chapters, up 1,184 from last year Areas that have seen substantial expansion are areas that have streamlined the support of existing, established programs to focus on growth opportunities These areas include Massachusetts, Connecticut, California, and New York, all of which have seen an increase of over 30% in chapter growth, as compared to the steady 4% the organization has experienced over the past decade Both new and established high school chapters have also been provided improved resources during the 2017-18 academic year These resources have been shared to engage and instruct chapter members on the necessary soft skills required create enriching friendships through Best Buddies matches, such as communication, diversity and inclusion, and empathy These trainings and materials have been offered as an extension of the Best Buddies' partnership with Sanford Harmony, which this year grew from elementary and middle school engagement to the high school level in 2017 As a result, new trainings for advisors and connection activities for high school members have been provided to our largest program, resulting in more sustainable, stronger friendships for our thousands of high school participants Best Buddies Middle SchoolsThe Best Buddies middle school program continues to see interest and growth as our programs expand to new youth models in elementary schools, resulting in more energy and attention paid to building friendship opportunities at feeder schools in these communities This is the second full year that the middle school program has utilized the tools provided by the Sanford Harmony partnership Harmony's social and emotional learning curriculum and resources have been instrumental in developing quality friendships and understanding of diversity amongst the youngest Best Buddies participants In addition to soft skills training with youth members, Best Buddies has made a determined effort to provide more advanced training for advisors at the middle school level Professional trainings in the areas of leadership, empowerment, transition programming, social and emotional learning, and philanthropy have been developed to ensure that administrators of our youth programming feel informed and prepared to invest in young leaders and create quality matches and opportunities for inclusion at their schools

Form 990, Part III, Line 4b:

Best Buddies Jobs continues the integration of people with intellectual and developmental disabilities into the community through supported employment. This program assists individuals to locate and maintain jobs of their own choosing by providing ongoing support and training. Our focus is on developing competitive, integrated jobs, which allow individuals to earn an income, pay taxes, and work in an environment alongside others in the community. The Best Buddies Jobs program continues to experience substantial growth and two additional US Jobs program locations were opened in 2017 including West Palm Beach, FL and Fresno, CA bringing the United States total to 19 Jobs Program locations. Development is underway in additional US states. The international Jobs program has six established locations: Santiago, Chile, Lima, Peru, Mexico City, Mexico, Sao Paulo, Brazil, and multiple cities in Colombia. Our newest program in Moscow, Russia opened in 2017. Development is underway in Qatar and the Netherlands for 2018. To date, Best Buddies Jobs has found employment for over 1,000 individuals via our Jobs programs in Albuquerque, Baltimore, Boston, Broward County, Capital Region, Chicago, Dallas, Fresno, Indianapolis, Harbor City, Las Vegas, Los Angeles, Miami, Nashville, New York, Orlando, San Francisco, West Palm Beach, and Worcester. We pride ourselves on developing jobs in professional, non-traditional work environments for people with intellectual and developmental disabilities. Our employers range from small businesses to some of the top fortune 500 companies like Albertsons Companies, Andeavor, FedEx, Hilton Worldwide Holdings, PetSmart, Pfizer Inc, Target Corporation, TJX, the parent company of TJMaxx and Marshalls, and Sprouts Farmers Market. We launched a national partnership with Levy in 2017 and they currently employ 10 participants with a commitment to hire more. 154 jobs were secured in 2017 with an average wage of \$11.48 and 20.3 hours per week. The overall retention rate for 2017 jobs was 93%. The current program-wide average wage is \$12.25/hr and the program-wide average hours per week is 22.2 for a total of 453 actively employed participants. Best Buddies Jobs also partners with the Miami-Dade Public Schools, Albuquerque Public Schools, and the Los Angeles Unified School District to support students who are interning at Zoo Miami, City of Miami, City of Hialeah (a suburb of Miami), University of New Mexico Hospital and Embassy Suites in Albuquerque, NM, and Kaiser Permanente South Bay Medical Center in Harbor City, CA. In 2017, Best Buddies Jobs partnered with Central Valley Regional Center to start our first adult Project SEARCH program at Community Regional Medical Center in Fresno, CA. Our employment consultants assist students to learn marketable skills during their one-year internship program and then find jobs for them in the community. These seven programs are replications of the internationally recognized high school transition program, Project SEARCH, which is based at Cincinnati Children's Hospital Medical Center. In 2017, our sites at Kaiser Permanente South Bay Medical Center and University of New Mexico Hospital received awards for outstanding employment outcomes at the annual Project SEARCH conference. In 2017, three Best Buddies Jobs offices went through a rigorous accreditation process by CARF International. This accreditation is required by some state agencies as it demonstrates a provider's commitment to providing high quality services and continual quality improvement. Two offices - Albuquerque, NM and Indianapolis, IN - went through this process for the first time. All offices received a 3-year accreditation, the best possible outcome. Best Buddies Jobs is preparing for two state accreditations in 2018.

e-Buddies- 919 Buddies, 892 Volunteers, 1,811 total active members - 1,092 unique matches - 41,038 e-mail messages exchanged - 345 posts on message boards - 81 school groups, 32 non-schools groups with active members - Participants in 46 US states (and the District of Columbia) and 13 other countries The e-Buddies program matches people with intellectual and developmental disabilities in one-to-one e-mail friendships with peer volunteers who do not have intellectual or developmental disabilities Participants include youth and adults from 50 US states, as well as international participants from the countries Australia, Austria, Canada, China, Germany, Ireland, New Zealand, Saint Kitts and Nevis, South Africa, Spain, Turkey, United Arab Emirates and the United Kingdom In 2017, e-Buddies served over 1,800 total participants through 1,092 unique one-to-one matches These participants exchanged over 41,038 e-mails - up over 1,000 emails from last year - and posted more than 345 messages on the e-Buddies community message boards This past year, e-Buddies made a concerted effort to enhance interest and participation from school advisors and special education classes The e-Buddies program - which offers literacy training, computer skills, and social opportunities in a safe and regulated environment - has been instrumental to teachers with students looking to develop these skills and valuable to classroom investment in the program Partnerships with organizations like Carnival Cruise and now OATH, both of which whose companies are committed to pairing staff in the e-Buddies program, have resulted in new recruitment strategies with Best Buddies staff and host sites, and new advancement of program involvement, thus providing more opportunities for friendship and inclusion at the youth and adult level
