Developing Leaders and Activists to Guide our Struggles In addition to offering financial and technical support to our network of coalitions, we also provide leadership development and training opportunities for staff and leaders of our network and facilitate cross-train opportunities across our network. Through our National Training and Leadership Development program we involve our national staff and network in new forms of organizing and strategic innovative thinking to advance overall organizing efforts, expand, and strengthen existing relationships to advance their work. Since the launch of the program we have trained nearly 1,000 leaders, organizers, and activists.
