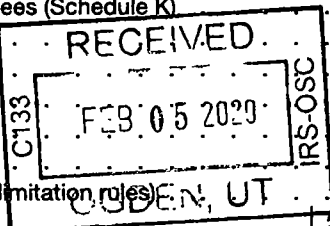

Part I, Line 12, Other Income:

Under the Tax Cuts and Jobs Act (TCJA), colleges were required to report unrelated business taxable income that resulted from providing parking to its employees. The amount previously reported on Line 12 represented that income, computed under the guidance of Notice 2018-99.

President Donald Trump signed legislation on December 20, 2019, repealing Internal Revenue Code Section 512(a)(7), commonly referred to as the "parking tax". The repeal is retroactive to the original date of enactment. As a result, organizations are entitled to a refund of taxes paid since the provision's original effective date was January 1, 2018.
