While the core of Jacob's Ladder, Inc programs is an annual summer enrichment program, held this year in Petersburg at Richard Bland Campus of College of William and Mary, there are other parts of the enrichment program which are held throughout the year. This year the program included 63 climbers. The summer program is held on a formal campus environment. There are other field trips during the year as part of follow up activities to make sure the young people are staying on track. Resident advisors serve as mentors, contract teachers are hired for the education programs and senior staff combine with these groups to assist with the role of life coaches. In addition to the summer programs, Jacob's Ladder staff serve to follow up on student progress through one on one and group meetings. This year, summer staffers were paid as W2 employees and instructors were paid as contractors, given the short span of time they are performing services for Jacob's Ladder Climbers. Group meetings may be combined with a field trip or travel to cultural events. These group meetings plus one on one follow up help the climbers to stay on track with their goals and to engage with staff, alumnae, peers and prospective Climbers. Two brand new vans, purchased with grants in late 2015, were again used in transporting Climbers and so the cost of operating the vans and depreciation increased on those vehicles critical to the mission. Jacob's Ladder, Inc hired an Executive Director in 2017 and the employee relationship was terminated as the entity continued its search for a better fit for the long term. A new Executive Director has been hired in 2018.
