Incoming donation bags were 17,848 and outgoing to trash was 4,652. Equipping the saints got 51,312 pounds or 25.656 tons, 30 suitcases, 4 pair of crutches, 1 walker, and 1 sewing machine - 425 boxes of books were donated to Regional Library as well as 500 paperbacks. The merchandise given from the store included needy families, schools, churches, mission trips, and giving helping hands to others. We sell our gently used sports equipment to a sports store in Charlottesville since they can get a higher price than we can. We also try to put on consignment some specialty items since they can get a higher price than we can.

There are many families who depend on our store to clothe their children since we are the "best buy in Albemarle County". We have customers who drive great distances of over 100 miles to come to our specialty weeks. We feel blessed in our success as a business that has been in operation for almost 40 years. It has been divinely blessed for the good we are trying to do.

Our reserves are blessed to help us prepare for the need of relocation, possibly in the next 3 years. We all believe in this mission.

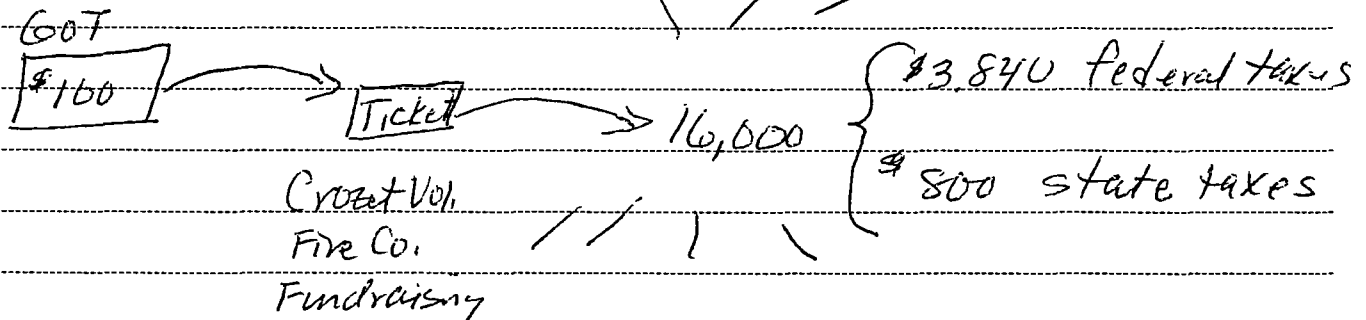
