Due to favorable conditions in the stock market overall, the net asset values (NAV) of our investments increased significantly in 2017, as reported to us on our quarterly statements. The overall change in NAV was a positive \$36,780.

Part IV Friends of the Dominican Republic is an all Volunteer organization. We have no employees.

Part III Statement of Public Service Accomplishments

The grant activities summarized in Part III all took place in the Dominican Republic. However, these should not be construed as "foreign" grants, because the funds were actually channelled directly through the Peace Corps Partnership Program, which is part of Peace Corps headquarters in Washington. Once transferred, the funds are considered to be Peace Corps funds and are used by Volunteers and their counterparts to improve their homes and communities.

Part I Line 16 Other Expenses

The organization incurred "other expenses" in the amount of \$1194. The majority of these expenses are for contractors who provide website hosting, domain name updating and website content updates. The remainder are small fees for Pay Pal and Network for Good, the Virginia Corporation Commission, as well as software licenses and updates, and other typical administrative expenses.
