ITS CONTRIBUTIONS HAVE HISTORICALLY BEEN AROUND \$1,000 - \$2,000 PER YEAR. OTHER FUNDS ARE RAISED THROUGH SPECIAL EVENTS SUCH AS A PANCAKE BREAKFAST AND A CHARITY RIDE. CCSAT'S ACTIVITIES ARE LIMITED TO A SMALL COMMUNITY (COCHISE COUNTY) AND A SPECIAL FIELD (LAW ENFORCEMENT), WHICH APPEALS TO A LIMITED NUMBER OF PERSONS. BECAUSE OF THIS, HISTORICALLY IT HAS NOT RECEIVED A LARGE NUMBER OF CONTRIBUTIONS AND HAS ALWAYS BEEN ABLE TO FILE FORM 990-N BETWEEN 2014 AND 2017. A SINGLE DONOR GAVE SEVERAL LARGE CONTRIBUTIONS FOR SPECIFIC PROJECTS AND TO ENABLE CCSAT TO IN TURN MAKE CONTRIBUTIONS TO OTHER COMMUNITY ORGANIZATIONS. CCSAT DOES NOT EXPECT THE SUPPORT FROM THE DONOR TO CONTINUE. PRESIDENT JOHN BLACK IS A RETIRED ARMY COLONEL WHO VOLUNTEERS WITH MANY OTHER LOCAL COCHISE COUNTY CHARITIES. HE IS ON THE BOARD OF DIRECTORS OF A VETERAN'S ORGANIZATION AS THE SCHOLARSHIP CHAIRMAN, IS A MEMBER OF THE SIERRA VISTA ROTARY CLUB AND SERVES AS AN OFFICER OF THE CLUB. HE IS A COACH AND FUNDRAISER FOR A TEAM THAT RIDES IN THE EL TOUR DE TUCSON, WHICH RAISES FUNDS FOR THE ERADICATION OF POLIO. IN ADDITION, MR. BLACK IS THE SECRETARY OF THE AMERICAN SOUTHWEST CREDIT UNION AND HAS SERVED ON THE BOARD FOR 20 YEARS. ASCU IS THE LARGEST CREDIT UNION SERVICING SOUTHEASTERN ARIZONA. TREASURER JIM BEHNKE IS A RETIRED ARMY LIEUTENANT COLONEL AS WELL AS A RETIRED PASTOR AND CIRCUIT COUNSELOR WHO SUPERVISED 10 OTHER CHURCHES AND PASTORS. HE STILL SERVES AS A CIRCUIT RIDER, FILLING IN AS A GUEST PASTOR IN MANY LOCAL CHURCHES AS NEEDED. HE IS A RETIRED MEMBER OF THE MISSOURI SYNOD LUTHERAN CHAPLAIN'S BOARD.
