The Foundation was created as a result of the June 1, 2017 sale of Ohio Valley Medical Center ("OVMC") and East Ohio Regional Hospital ("EORH") to Alecto, a for-profit health care system. Therefore, the Foundation was created to carry out the charitable outreach activities of the former not-for-profit OVMC and EORH. On March, 19, 2018, the Foundation was designated by the Internal Revenue Service as a tax-exempt non-profit 501(c)(3) public charity. Therefore, most of the 2017 and early 2018 calendar years involved working on making the appropriate steps to rename and reclassify the Foundation. The Foundation is currently working to award annual grants in order to assure community needs are met and, thus, the Foundation is developing a formalized competitive grant process which will be announced and shared with public charities within the communities the Foundation serves. The Mission of this Foundation is to improve the health and well-being of the residents of the Ohio Valley.
