Enterprise Properties, Inc. has been instrumental in keeping CASCI in Charleston, and has helped the local economy by retaining over 600 jobs with an annual payroll exceeding \$20 million. CASCI continues to project annual growth in jobs for the community. Cash flow from the lease allows Enterprise Properties, Inc. to disburse economic development grants to an affiliated non-profit organization in furtherance of its economic development mission.
