THE CENTER'S PURPOSE IS TO PROMOTE AWARENESS OF THE VALUE OF MEDITATION, CONTEMPLATION AND SILENCE AS A WAY TO UNCOVER THE TRUTHS WITHIN THE HEART. DURING THE YEAR, THE CENTER CONDUCTED 25 MEDITATION RETREATS VARYING IN LENGTH FROM 2 - 7 NIGHTS, FOR A TOTAL OF 115 RETREAT-NIGHTS. THE RETREATS WERE CONDUCTED BY 27 TEACHERS AND ATTENDED BY 554 PARTICIPANTS. TEACHERS PRIMARILY REPRESENT A VARIETY OF BUDDHIST TRADITIONS, BUT ALSO INCLUDE OTHER OFFERINGS. ATTENDEES TAKING ADVANTAGE OF SCHOLARSHIP OFFERINGS TOTALED 49, OR APPROXIMATELY 9% OF ATTENDEES.
