On September 25, 2017 the Jeff Gordon Children's Foundation announced the establishment of the Jeff Gordon Children's Foundation Endowed Chair in Cancer and Blood Disorders at Carolinas HealthCare System, now known as Atrium Health. The endowment will support the current and future academic and research efforts at Levine Children's Hospital providing the academic and scientific freedom to move forward, pursue new treatment options and discover the next generation of medical science. The Center accepted 140 new cancer patients in 2016 and received over 14,900 outpatient visits - making it one of the busiest and most respected hematology, oncology and blood and marrow transplant (BMT) programs in the Southeast.
