Green Built Homes and LEED Homes programs provide education and certification for green buildings meeting program criteria - 211 home certifications completed in 2017. Distributed 25,000 copies of Green Built Alliance Directory (with a readership of 80,000).

The Green Built Alliance serves as an active member of the Energy Innovation Task Force. This partnership between the City of Asheville, Buncombe County, Duke Energy and local partners will reduce local demand for fossil fuels and build efficiency programs. The Green Built Alliance's Appalachian Offsets program is raising money through carbon offsets to install a photovoltaic system on the roof of a local elementary school to help them achieve their goal of net zero energy.
