Youth Leadership Network Student Sponsorship Program

This program in Kenya worked with 35 students throughout 2017. The kids range in age from nine to 22 and would have no other way to pay for school fees and related costs were it not for the program. These students show promise and dedication to their studies. The goal of the program is to see students achieve a full high school education and we have many now who have reached that goal and are continuing on in college / university. The majority of these students are in boarding school to provide proper shelter and a safer place to live and study. This program is also providing year-round shelter for several students and medical costs as they arise. The program also hosts annual retreats for the boys and girls to provide life-skills education, counseling and connection with other participants and a place to grow, share and develop into responsible and knowledgeable adults.

Kenyan Women's Network

Our women's cooperative program is our largest program in terms of participants (partners). This program focuses on the social and economic empowerment of women living in extreme poverty in Kenya. Major accomplishments in 2017 include partnering with 4 new cooperatives, made up of a total of 111 women in western Kenya. Each woman attends 6 months of education to increase basic knowledge of critical life-skills through training in human rights, leadership and personal development, basic livelihood knowledge through business skills and bookkeeping education and improving overall health and nutrition levels through training in personal hygiene, basic nutrition and reproductive health. Following the 6 months, each group enters the small business growth phase to improve income levels and overall living standards. We partner with each group for a period of 3-5 years after the initial 6 months training period. These 3-5 years include revolving funds for small business growth, monthly monitoring, follow-up workshops and business coaching. We had a total of 21 continuing groups and a total of 710 women in the program in 2017.

Youth Leadership Network Young Women's Leadership Challenge (YWLC) - U.S. in Texas

This program provides an opportunity for high school aged young women to learn about themselves, develop leadership skills and understand their ability to improve not only their own lives but the lives of others through intentional service. This is a year-round program that begins with a 6-day conference. The capstone of the conference is the creation of their own service project, called their Take Action Challenge (TAC), which they will plan, implement and execute during the following school year. We provide mentors for each of the young women, fall and spring meetings and access to lectures, speakers and other community engagements. In 2017, we expanded to Austin, and Dallas and continued our growth in Houston. There were a total of 65 participants in 2017. Of the 65 participants, 39 received need-based scholarships to attend the program, which means that the program fee was waived to ensure their participation in the program.

All program activities conducted at the local level in Kenya are monitored and reviewed by local Pangea staff, an outside accountant and by the Pangea Network HQ staff and the board. Monthly requisitions for funding are received from the Kenya office, reviewed and once approved, wired to cover that month's program and administrative expenses. A monthly review is conducted by the accountant in the region, reviewing receipts and expenses against budget and sends an actual expenditure report, along with bank statements to the U.S. HQ, which are then reviewed by the Pangea head in Texas.

Also, as required by Kenyan law, the Kenyan books are audited annually by independent auditors.

Program staff in Kenya do monthly monitoring of all active women's cooperatives and review financial statements and also do random site visits of their businesses if they are receiving revolving funds.

Pangea HQ staff visit the field office on an annual basis for site visits with staff to the women's cooperatives and student sponsorship recipients to ensure program execution, impact and efficiency. We also review all policies and procedures, conduct performance reviews, etc.

Program investments of \$54,051 are funds given to the cooperatives after their 6-month training is completed. These are disbursed as a revolving source of funds for the women to start and grow small businesses and increase income levels.
