The terms of the plan require the participants to remain employed by the Credit Union until an agreed upon retirement date. The plan constitutes an unsecured promise by the Credit Union to pay benefits in the future to the participant and the participant shall have status of a general unsecured creditor of the Credit Union. The deferred compensation accounts are shown as both assets and liabilities on the Credit Union's financial statements and are available to creditors in the event of the Credit Union's liquidation. Any interest earned by, or return on such investments shall be credited to the participant's plan account at least annually. The plan benefits shall be paid as a lump sum as soon as administratively practicable following the earlier of the participant's normal retirement date, the participant's involuntary termination of employment without cause, or the termination of the plan pursuant to the appointed committee's discretion. Participants are eligible based on approval by the Credit Union's Board of Directors. Under this plan, participants are given access to employer funds to be invested in certain investment vehicles. The participant's benefit is the earnings of those investments above the initial investment balance. The asset and liability related to this plan approximated \$2,723,000 and \$2,723,000 as of December 31, 2017 and 2016, respectively. The following individuals, reported on Form 990 Part VII, had contributions made on their behalf into the Sec 457f plan by the Credit Union: Greg Connor \$48,000; Thomas Maiellaro 21,000; Jim LaFond 28,800; Beth Tynan 9,600; Todd Chandler 8,400. The Credit Union has split-dollar life insurance plans for a select group of Management. The Credit Union has secured interest in these plans to the extent of premiums advanced on the behalf of these key employees. The vested interest in these split-dollar plans totaled approximately \$4,969,000 and \$4,195,000 as of December 31, 2016 and 2015, respectively.
