A LACK OF CONSISTENCY EXISTS IN THE APPLICATION OF BEST PRACTICES FOR EARLY INTERVENTION, EDUCATION, AND INCLUSION OF INDIVIDUALS WITH DOWN SYNDROME IN OUR COMMUNITIES, SCHOOLS, AND WORK ENVIRONMENTS. MANY COMMUNITIES ACROSS THE COUNTRY PROVIDE INDIVIDUALS WITH DOWN SYNDROME ACCESS TO THE SAME EDUCATIONAL, RECREATIONAL, RESIDENTIAL AND EMPLOYMENT OPPORTUNITIES AVAILABLE TO THOSE WITHOUT DOWN SYNDROME.
