trust. Once the trustee decides which organization he will send support to, he requests a copy of their 501(c)(3) IRS Exemption notice to confirm the supported organization's non-profit status. Once non-profit status is confirmed he will submit a check for an amount he determines necessary for the supported organization. There is a continuing relationship the trustee has with several discretionary supported organizations. The trustee has given funds to several organizations each year that are not required by the governing documents and these organizations have come to rely on these funds from the trust.

In 2016, the trustee acted on this authority and reduced the percentage given to the American Lung Association of NC to 0%; therefore, this organization did not receive any funds from the trust in 2016. In 2017, the trustee followed the percentages in the governing documents and issued the full percentage of trust income allocated to the American Lung Association of NC. The remaining 30% of support funds distributed by the trust are given at the discretion of the trustee, so those organizations receiving this funding can change yearly.
