Form 990-EZ, Part I, Line 10 - For Grants and similar amounts paid - \$51,620 - these funds were spent for client expenses in the following areas: \$30,000 for their utilities; \$12,572 for food; \$5,328 for rent; \$2,380 for medicine; and \$1,340 for doctors and misc. We are lucky to be part of a caring community with some major food contributors as well as churches and organizations that give us funding for our clients. All of our staff is composed of volunteers; no one is paid. Most of our funding goes directly to client services.

Form 990-EZ, Part II, Line 24 - \$29,085 - these include walk-in cooler/freezer, 4 stand alone refrigerators, shelving, cabinets, office equipment and an outside storage building.

Form 990-EZ, Part III, Line (28-31) - 1,146 clients and their household members received help in 2017. Visiting an average of 5 times during the year those clients received 30,913 unduplicated services including help with their utility bills, rent, medical needs, food, clothing etc. (Ex: a family of 3 who came to our agency and rec'd food for 3, clothing for 3, and one voucher for utilities, that = 7 services on that visit. If the client visited a total of 5 times during the year then she and her family would have rec'd 35 unduplicated services during 2017.) Grants (funds spent totally on client expenses) totaled \$51,620. That same number could be listed as Expenses, because all the funds were expended for the clients. Administrative expenses were separate and listed on lines 13, 14 & 15 in Part I.
