As of December 31, 2017 and 2016, there are no known items which result in recording a liability related to uncertain tax positions. Tax years 2013 through 2017 remain subject to examination by major tax jurisdictions (US Federal, state and local authorities). The Foundation has considered the provisions of the Tax Cuts and Jobs Act (the "TCJA"), which was signed into law on December 22, 2017 and which generally takes effect for taxable years beginning on or after January 1, 2018. While the Foundation determined that there was no impact of the provisions of the TCJA on the Foundation as of December 31, 2017, the impact going forward is uncertain and may not become evident for some period of time, as regulatory guidance has not yet been issued.
