Part VI 5. On March 22, 2017, the Hugh G. Ashcraft Foundation's (HAF) Board of Directors became aware that a fellow Director had abused

her position of trust to divert HAF funds to her own benefit. HAF retained counsel and forensic accountants to uncover the full

scope of the Director's fraud, and learned that the Director had falsified and modified HAF applications and caused checks to be

issued to her own mortgage and utility companies to conceal her misappropriations. A total of \$77,984.57 was diverted over a

period of several years.

Corrective action taken included the following: (i) turning the matter over to federal authorities for prosecution of the Director;

(ii) adopting new procedures regarding the approval and mailing of checks; (iii) creating an Executive Committee with oversight

over an annual audit process; and (iv) requesting restitution from the Director in connection with her sentencing.

The Director pleaded guilty to wire fraud in October 2017. She was sentenced in May 2018 to prison, and is required to make full

restitution upon her release.
