During the second half of 2017, RiverLink continued its high-impact work by encouraging watershed communities to experience and learn about the French Broad River. We also carried out critical water conservation programs. CONSERVATION - we worked with the NC Clean Water Management Trust Fund and the City of Asheville to complete the \$400,000 dollar Stormwater Control Measures Project on the campus of the New Belgium Brewery. RiverLink also provided \$25,000 dollars in-kind volunteer service to the project that installed 5 Stormwater Control Measures on the brownfield site. The Givens Estates Innovative Stormwater Control Project, funded by NC Clean Water Management Trust Fund, entered the research and data collection phase that will result in 5 Stormwater Control Measures being designed and installed to control runoff in the 100-acre watershed that flows into the impaired Dingle Creek. A

UNC Asheville McCullough Fellow assisted with volunteer workdays, soil and sediment load sampling, and provided tours to the public to learn more about the project. We released a Request For Qualifications to begin the process of selecting a Design Firm to create the Master Plan for the future Karen Cragolin Park on the site of the former EDACO Junkyard. A stakeholder team was recruited from funders, the City and other important members of our community to inform and assist in the design selection process. A selection will be made in the first quarter of 2018 with the design process set to being in May 2018.

LEARN - As envisioned in the 2015 Strategic Plan, we hired a Programs Manager to provide a permanent staff member to oversee both Education and Volunteer Programs. This allowed us to reach more than 2,000 children in the last six months of 2017 and we

finished the last two sessions of the four for our popular RiverCamp, which also provided scholarships for 20% of the students who are on free and reduced lunches for school. We also provided rain barrel workshops, education series lectures with topics that covered river recreation/paddle trail, residential rainwater runoff, and flood preparedness.

EXPERIENCE - We continued a strong legacy of providing ways for watershed communities to experience the watershed. The hiring of the program manager created a consistent staff presence to grow the effectiveness of our volunteer programs that included a revitalization of an existing adopt-a-stream program and greater emphasis on group activities that can be used as in-kind match for major projects like the Innovative See Part III, Ln 4c statement
