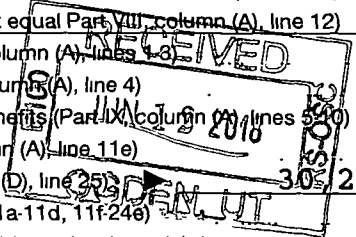

BLACK & FEMALE LEADERSHIP TRAINING INSTITUTE -- BPI continued its leadership training institute in 2017 where 18 Black women and 3 Black girls attended 4-day trainings in February, June and October 2017. Participants meet every quarter to continue establishing a community of practice using the Be Present Empowerment Model(R) to continue building trust and strengthen relationships among women and girls from diverse backgrounds. The trainings also strengthened collective leadership skills and increased the visibility of the leadership of Black women and girls in diverse social justice movements. Six women, who comprise the B&F Leadership Team, arrive on the Monday of each training, to continue their training in the Be Present Empowerment Model(R) and prepare for the arrival of the 15 other women and girls

4b (Code) (Expenses \$ 101,784. including grants of \$) (Revenue \$ 6,600.)

NATIONAL NETWORK AND LOCAL DEVELOPMENT -- BPI conducts several activities under this category:(1) NATIONAL NETWORK TRAINING for facilitators and trainers from across the U.S. to strengthen the national BPI network and provide further training on the issues. Approximately 35 women, girls, boys and men attended the 2017 National Network Training. (2) HEARTS IN ACTION - a 3 day workshop in Yellow Springs, OH, organized by BPI and its Local Organizing Core Group to introduce the Be Present Empowerment Model(R)(BPEM)to the Yellow Springs community, including Antioch College. Approximately 61 people attended. The workshop also supported the expansion of the local support group network in the area. (3) FAMILY CAMP - a 3 day workshop in Oakland, CA, organized by BPI and its Local Organizing Core Group.

CONSULTING SERVICES TO NPO's - BPI has created partnerships with many of the NPO's to which it has provided consulting services in the past. In 2017, BPI continued supporting its partner, the Women & Gender Studies Program and Coalition for Social Justice, University of Oklahoma-Norman. The Women & Gender Studies Program and Coalition for Social Justice was hosting its annual "Take Root" Conference. BPI designed and conducted a pre-conference training for staff and allies entitled "Be Present: Leading Collaboratively at the intersection of Race, Gender, Class & Power." Approximately 35 people attended.
