Other Program Services: Housing/Capital Expansion \$194,050. Student housing and additional instructional facilities remain critical ingredients for the College's expansion and growth. The Foundation must continue to secure gifts to support new and improved facilities and the future phases of student housing. Currently the Foundation owns and operates Coastal Place Apartments, which is an 88 student off-campus housing unit in conjunction with the College's residential housing program. There are various naming opportunities through capital donations for new and existing campus buildings and infrastructure (e.g., walkways, water features, laboratories, student meeting areas) that can be targeted for future solicitations.
