ONCE MR. AND MRS. BRYANT RECEIVED IRS NOTICE CP259B RELATING TO THE 2018 RETURN, THEY IMMEDIATELY DISCOVERED THE 2017 RETURN WAS ALSO NOT FILED. THEY CHANGED THE FOUNDATION'S ACCOUNTING FIRM AND HAD THE FORMS PREPARED BY THE NEW FIRM. THE BRYANT'S LOST TRACK OF THESE RETURNS AND DID NOT INTENTIONALLY FAIL TO FILE THEM AND WILL BE MORE AWARE OF THE RETURN FILINGS IN THE FUTURE.
