Providing programs focused on pro-social tendencies and behaviors, Horizon has developed a safe living atmosphere designed to help inmates live responsibly with others and preparing them for re-entry without recidivism. Those inmates lacking a GED or basic computer skills are given the opportunity to prepare and learn with the aide of our computer labs that are built into the living quarters. We have provided over 4600 classes to more than 900 inmates in the past year.
