Medical Malnutrition Center - In 2017, 8,640 patients were served in the 17,000 square foot Medical Center, providing a broad range of medical services to the community, including emergency care, intake and assessment, diagnostic services through blood analysis, a radiology lab, outpatient treatment, inpatient treatment for intensive malnutrition cases, an on-site pharmacy and medical transport to and from the Center. The Centers Dental Clinic served 1,272 people with a full complement of dental hygienic, preventative and restorative services, as well as the distribution of dental care supplies. Health and wellness education was provided to 8,807 people on disease prevention and wellness maintenance. The Centers Malnutrition Center served 347 malnourished children and saved the lives of 167 critically-ill children who were near death from starvation through a medically-supervised, 3-month inpatient nutrition and medical care regimen and a minimum 6-month follow-up program to ensure continued wellness and other outpatient services to monitor patients food security.

Form 990, Part III, Line 4b:

Education - In 2017, The Danitas Children School, a private, non-denominational institution, educated 316 students, pre-school through Grade 13. Of these students, 84 were orphans who lived in the Childrens Homes while the remainder come from the surrounding community of Ouanaminthe. The School provides supplies, books, uniforms, and medical care for each child attending school. The curriculum follows Haiti's Ministry of Education curriculum requirements, while incorporating U.S.-based educational methodologies for analytical reasoning and problem-solving. Students learn Creole, French and English. The School also has an official sports program, allowing the students to participate in competitive sports such as soccer and volleyball. Thirteen students successfully graduated the High School and entered the Danitas Children Higher Education Scholarship Program, which provides financial, logistical and directional support and guidance for students to attend and successfully complete college. In total, 15 students were sponsored to attend college in Haiti and 5 in the U.S.

Form 990, Part III, Line 4c:

Childrens Homes for Orphans - In 2017, Danitas Children provided full-time care for 84 orphans through the Organizations 6 Childrens Homes. The Childrens Homes are independently operating households with a House Parent and 12 to 15 children living in each Home, thus allowing House Parents to provide a nurturing family-type setting for the children. Through the Childrens Homes, the children received safe and comfortable shelter, nourishing food more than 3 meals per day, clothing including school uniforms, and emotional and spiritual care and support.
