Management has reviewed all tax positions recognized in previously filed tax returns in the U.S. federal and state jurisdictions and those expected to be taken in future tax returns. As of December 31, 2017, the Association had no amounts related to unrecognized income tax benefits and no amounts related to accrued interest and penalties.
