"The ABC Curriculum" is a Media Bible Training Project that contains 4 modules of Bible Training in the Basics of the Christian Faith covering Discipleship, Christian Doctrine, Old and New Testament Studies and Pastoral Training in order to train future Chinese Pastors, Church Planters and Christian leaders. Each "ABC Curriculum" is recorded on 19 audio discs on MP3 formatting that contains 300 hours of Bible Training, an instruction manual, 16 study books and a study guide complete with questions and tests. This outreach program will reveal the love that Jesus Christ has for each of these women and reveal and demonstrate His love for women to a society that demeans, mistreats and abuses women and that ignores their human rights.
