OUTREACH SERVICES: (Chapel services, meals and clothes, housing and employment counseling, life skills trainings, case management, and health clinic services): There were 41,247 meals served in 2017. 1,203 people were connected with resources through walk-in hours, and 83% of those clients had their acute needs met. All guests were made aware of additional services the mission has to offer, 200 were referred to another program within the mission, 88 followed up with the appropriate staff person, and 55 were accepted into a mission program to address their deeper needs and help them take steps out of poverty. Through Outreach Services: 12 homeless families moved into housing; 102 evictions or utility shut-offs were prevented, 103 patients received free medical care; 1,203 people were provided clothing, toiletries, and other basic necessities; and 163 people were led in spiritual formation.

4b (Code:) (Expenses \$ 193,027 including grants of \$) (Revenue \$ 12,571)RESTORATIVE SERVICES: (Residential services for men in transition):

The mission housed 45 men at the Potter's House. 69% obtained gainful employment, 98% did not return to jail, 82% maintained their sobriety, 46% met formally with the chaplain for spiritual care, 51% completed a budget, 90% attended weekly relapse prevention meetings, 84% attended church regularly, 78% attended support groups, and 59% developed a supportive social network. In 2017, 45 men were housed at the Potter's House. Also in 2017, the mission purchased and rehabilitated a property at 629 North Broadway (Lexington) that will provide transitional lodging for an additional 18 men beginning in 2018.

Many people struggle with finding and keeping meaningful employment. In 2017, the mission employed 56 job-seekers in 103 temporary assignments through the Advance Lexington program. Also, 40 job-seekers were placed directly in permanent jobs. 74% of the temporary workers and 72% of the permanent placements continued to be employed at the end the first quarter of 2018.

Grants paid on behalf of individuals are regularly monitored throughout the year, based on board-approved budget. Applications for rent and utility

assistance are completed including supportive documentation. The Executive Director approves payments and signs checks made payable directly to the

landlord or utility company on behalf of the client. Patient prescriptions are written by the nurse practitioner manager or volunteer and are processed and

invoiced through a pharmacy vendor. Local bus passes and gas cards are purchased in advance by each respective Division Director. These passes and gas

cards are distributed to eligible clients according to need. Other assistance includes helping clients secure identification cards, copies of birth certificates and

transcripts so they can obtain employment. Christmas gift food baskets for poor families were distributed. A case manager personally interviews and assesses

their need for help. In some cases, payments are made online, by credit card, and other cases payments are made through a requisition for petty cash. Each

purchase is recorded by the case manager on a spreadsheet with identifying information, type of assistance and the amount.

Part III, Line 4d: This program service includes REENTRY SERVICES, also known as our Breaking Chains program. This area reaches out to men and women who are incarcerated with the love of Christ, disciples them, and equips them to live healthy, productive lives in our community when they are released. Classes are offered in both jails and prisons, including Fayette County Detention Center, Woodford County Detention Center, Jessamine County Detention Center, and Northpoint Training Center. These classes -- The Genesis Process and Jobs for Life -- help inmates confront the root causes of their criminal behavior and give them tools to succeed upon release. Upon release, Breaking Chains provides case management to help these men and women create a reentry an individualized reentry plan and supports them as they take steps to achieve their goals. In 2017, 116 men and women met with our case manager for 442 visits. Of those 116 people, 89 completed at least one of their goals in their reentry plan (housing, employment, family reunification, etc.) Of these 89 clients, 5 recidivated and returned to incarceration.

The committee presents its findings and recommendations to the full board for its approval, which is documented in the board's meeting minutes.
