PROGRAM (AN EMPLOYMENT PROGRAM WHERE TEENS WORK FOR NNH WHILE PARTICIPATING IN CLASS REINFORCING POSITIVE LIFE & JOB SKILLS). THE STUDENTS ARE REFERRED THROUGH THE PRINCIPALS & GUIDANCE COUNSELORS OF THE SCHOOLS SERVED. THESE ARE CHILDREN WHO ARE STRUGGLING EITHER SOCIALLY OR ACADEMICALLY AND NEED EXTRA SUPPORT.
