Ecovillage Training Center: In conjunction with the United Nations Institute for Training and Research (UNITAR), Global Ecovillage Network and Gaia University, the Institute educates international students and transfers technologies through an immersion pedagogy of ecovillage living, classroom activity and hands-on skill-building exercises, together with workshops, lectures, practical demonstrations, publications, and outreach on six continents. In 2016 GVI provided more than 50 public lectures and 10 extended workshops (including Belize, EU, India, Mexico, Palestine, US and UK), and produced numerous publications and course workbooks. For these purposes GVI maintains an office and training facility in Tennessee.

4b (Code:) (Expenses \$ 22500 including grants of \$ 22,550) (Revenue \$)
Culture Change: The only realistic response to the "hyperwicked" problems of climate change, peak oil, population explosion and the converging limits to growth is not scientific or technological but cultural. Culture Change is GVI's project to chart a new course to the era after petroleum; a car-free, air travel-restricted world of renewable energy, sail and rail. Among the projects GVI sponsors are the Sail Transport Network and an effort to reduce the use and disposal of non-biodegradable plastics. An internet-based journal, Culture Change, and a blog, The Great Change, document these efforts.

Regenerative Development to Reverse Climate Change is a partnership of intergovernmental, governmental and non-governmental organizations convened by the Commonwealth of Nations with the assistance of Cloudburst Foundation. Its purpose to develop green investment vehicles that reverse climate change. GVI sponsors NOAH ReGen to create a database of simple, shovel-ready, and scalable projects worldwide.
