The Foundation supports a variety of other patient care programs throughout Covenant Health. The two most significant of those are the Fellowship Center, (the Center), and Peninsula Behavioral Health, a division of Parkwest Medical Center. The Fellowship Center, an outpatient lodging facility supported entirely by contributions, offers free lodging for families coping with serious illnesses and includes eighteen furnished apartments, a community family room, stocked pantry, and laundry facilities. Thompson Cancer Survival Center patients and their families who live more than 30 miles from Knoxville have priority use of the Center's apartments. As space permits, the Center also welcomes outpatients from Patricia Neal Rehabilitation Center and referrals from area health care facilities. In 2017, \$77,413 in cash distributions supported the operational costs of the Center. Additionally, \$3,353 in gifts-in-kind were received and distributed to the Center, primarily pantry and household items for use by guests. The Center hosted 555 guests from across the United States in 2017 providing a total of 4,204 nights of free lodging. In 2017, funds raised through the annual Artsclamation! fine art sale and other donations supported three primary areas of behavioral health care at Peninsula Behavioral Health. Approximately \$38,000 provided discharge medications to patients who need a supply of prescriptions when they leave the hospital to maintain their health until they are set up on TennCare or other payer sources for ongoing maintenance medications. Capital improvements totaling almost \$37,000 were funded, including the renovation and development of an indoor playground for pediatric patients at Peninsula Behavioral Health, outdoor bench seating at Peninsula Behavioral Health's Knoxville outpatient clinic, as well as supportive therapy supplies. Emergency assistance for housing, transportation, food, etc. of approximately \$15,600 was provided to 48 patients/clients in crisis.

Patricia Neal Rehabilitation CenterIn 2017, the Foundation supported a variety of needs at Patricia Neal Rehabilitation Center, (Center), a department of Fort Sanders Regional Medical Center. Distributions of \$170,553 funded 82 requests for patient care scholarships for uninsured patients with no other ability to pay who were in need of inpatient and outpatient care, as well as durable medical equipment. Patients are vetted both clinically and financially by Center staff before being selected for scholarship-funded care. Another approximately \$84,000 provided for patient therapy and treatment equipment at the Center, \$34,000 for adaptive recreation outreach efforts, and \$40,000 for staff academic scholarships and continuing education/certifications.

Form 990, Part III, Line 4b:

Covenant HomeCareDistributions to Covenant HomeCare include underwriting of the operations and services of the Hope Center, a program of Covenant Health, to address the unmet needs of patients infected with HIV/AIDS and their families. Distributions for 2017 operations of the Hope Center included \$121,009 in cash and \$35,153 in gifts-in-kind. These gifts-in-kind included both items donated for use at an annual auction fundraiser as well as patient care/support items donated for direct use by Hope Center clients. See Schedule O for more information. Expenses - \$206,234, Grants - \$206,234The Hope Center provides supportive care programs, counseling and referrals at no charge to inpatients, outpatients, and families affected by HIV. The Hope Center relies entirely on charitable gifts and donations for its existence. In the last 22 years, over 3,000 individuals and their families have received supportive services at no charge. Additionally, \$36,100 was distributed for the operation of Katerpillar Kids Camp, an annual grief camp for children provided free of charge by Covenant Homecare Hospice. Another \$13,972 was distributed to support HomeCare/Hospice staff education, patient/family education, patients in crisis, and bereavement support.

Form 990, Part III, Line 4c:

Fort Sanders Regional Medical CenterDistributions totaling \$71,750 to Fort Sanders Regional Medical Center supported neurovascular research studies. Distributions totaling \$47,907 benefited cardiopulmonary care efforts, including outpatient cardiac and pulmonary rehabilitative care and staff education regarding pulmonary disease. An additional \$22,691 provided three fetal monitors for high-risk, obese mothers in the hospital's labor and delivery department. Approximately \$43,000 was distributed for patient and employee emergency assistance. Emergency assistance funds are managed by the social services staff and chaplains at the hospital as a short-term intervention to ensure safety and continued healing for individuals in crisis.
