Fight injustice - 10/40 Connections battles the global epidemic of human trafficking through setting up surveillance stations and recovery homes in Nepal. We also address the lack of health education for women by offering our Voice for the Voiceless curriculum. In 2017 we started construction on a safe home in one city and also continued construction for the "Crown of Beauty" home for at-risk mothers/babies in another city in Nepal. We were able to rescue more than 300 women from trafficking, and our Voice for the Voiceless curriculum spread to more than 3,000 people in India, Nepal, and Thailand

4b (Code) (Expenses \$ 104,888 including grants of \$ 73,381) (Revenue \$)

Empower At-Risk Children - 10/40 Connections works to provide whole-life change, hope and protection to at-risk children through expanding educational opportunities. We continued our Lunch Change project which ran 22 schools in slum areas with 650+ children fed and educated daily. We also continued the Arise Home Project which supported 22 girls with education and a summer retreat

Equip Believers Internationally - 10/40 Connections provides relevant and practical theological instruction which impacts the whole person and the whole community. Our Ummeed Project developed more than 1,000 leaders through hosting 33 training sessions in multiple states of India. We also addressed the problem of illiteracy as we continued to run a mobile seminary with 4 teachers, 11 classes, and 175 students

For those who want to understand more about how to not only do good deeds, but also to have clean hearts, we are happy to share some good news. While most religions attempt to help people become better people or please God, we have found that Jesus Christ actually makes it possible. After he lived a perfect life - without one wrong word, thought, action or motive, Jesus allowed himself to die on the cross to pay the penalty for the wrong things people do. Three days later the resurrection of Jesus showed that he had power over death, and that people need not fear. Jesus offers forgiveness and a clean heart to anyone who would call on his name and live their life up to his. If you have questions, we are happy to discuss this further
